2. **2907.04** (M1) Unlawful Sexual Conduct with a Minor, nonconsensual and offender less than 4 years older than victim, not previously convicted of 2907.02, 2907.03, or 2907.04, or former 2907.12 (FSP)**

3. **2907.08** (M1,2,3, or F5) Voyeurism

4. **2907.06** (M3) Sexual Imposition

5. **2907.05 (A)(1)-(3), (5)** (F4) Gross Sexual Imposition

6. **2907.323 (A)(3)** (F5) Illegal Use of a Minor in Nudity oriented Material or Performance

7. **2905.05 (B)** (M1) Child Enticement with sexual motivation {new under SB 10}

8. **2907.32** (F5) Pandering Obscenity

7. **2919.22 (B)(5)** (M1 or F4, 2, or 3) Child Endangering

8. **2905.01 (A)(1)-(3), (5)** (F2) Kidnapping with sexual Motivation

9. **2905.01 (A)(4)** (F2) Kidnapping victim over 18

10. **2905.02 (B)** (F3) Abduction with sexual motivation {new under SB 10}

11. Any sexual offense that occurs after the offender has been classified as a Tier I offender.
